Cross Company Mentoring Launch



The Women's Leadership Forum Cross Company Mentoring 2016-2017 Program **officially launched in October 2016.** Here is an update on the program:

Matching Process

- In September, the committee reviewed all submissions and paired the mentors
- After finalizing the participants list, the committee hosted an in person kick-off meeting to introduce participants to the program and provide best practices for mentoring relationships. The committee provided all participants a contact list of

the matched pairs. Information included names of the matches, email, phone number and company that they work for.

We had a guest speaker, Elaine Francis from PNC who talked to the group about the importance of a mentoring relationship. We gave helpful hints and questions for the pairs to get to know one another and establish how they would conduct their relationship, i.e. where and when they would meet, would it be in person or over the phone, etc.

Program Overview

- Throughout the program, touch-point emails with tips and best practices will be sent out to the program participants to help keep the participants engaged and keep communication open between the committee and the pairs.
- The committee will schedule quarterly Cross Company Mentoring Connect Sessions at PNCs Eastwick Center. We will have topics to discuss, books to recommend and time for group and mentor/mentee discussion.
- The first quarterly session occurred on Tuesday, January 31st from 8:30 am 10 am at Eastwick Center. Our topic of discussion is The Power of No and Never Having to Say "Sorry". We provided several articles on these topics for everyone to read prior to the meeting and we have handouts as well. During the event, we had break out groups for discussion and then we re-grouped for the last twenty minutes to discuss our findings on the questions we provided to the groups.









Membership Feature: KPMG



This month's membership feature company is KPMG. Thank you to their members for providing this overview!

1. Tell us a little about your company

KPMG is a global network of independent member firms offering audit, tax and advisory services. KPMG was formed in 1987 with the merger of Peat Marwick International (PMI) and Klynveld Main Goerdeler (KMG) and their individual member firms. Spanning three

centuries, the organization's history can be traced through the names of its principal founding members — whose initials form the name "KPMG."

- K is for Klynveld Piet Klynveld founded the accounting firm Klynveld Kraayenhof & Co. in Amsterdam in 1917.
- P is for Peat William Barclay Peat founded the accounting firm William Barclay Peat & Co. in London in 1870.
- M is for Marwick James Marwick founded the accounting firm Marwick, Mitchell & Co. with Roger Mitchell in New York City in 1897.
- G is for Goerdeler Dr. Reinhard Goerdeler was chairman of Deutsche Treuhand-Gesellschaft for many years and later chairman of KPMG. He is credited with laying much of the groundwork for the KMG merger.

In 1911, William Barclay Peat & Co. and Marwick, Mitchell & Co. joined forces to form what would later be known as Peat Marwick International (PMI), a worldwide network of accounting and consulting firms. In 1979, Klynveld joined forces with Deutsche Treuhand-Gesellschaft and the international professional services firm McLintock Main Lafrentz to form Klynveld Main Goerdeler (KMG). In 1987, PMI and KMG and their member firms joined forces. Today, all member firms throughout the world carry the KPMG name exclusively or include it in their national firm name.

The firms work closely with clients, helping them to mitigate risks and grasp opportunities. Member firms' clients include business corporations, governments and public sector agencies and not-for-profit organizations. They look to KPMG for a consistent standard of service based on high order professional capabilities, industry insight and local knowledge.

KPMG member firms can be found in 152 countries. Collectively they employ more than 189,000 people across a range of disciplines. Sustaining and enhancing the quality of this professional workforce is KPMG's primary objective. Wherever our firms operate, we want them to be no less than the professional employers of choice.
